Executive Director (Engineering) & Executive Director (Procurement)

The Dhaka Electric Supply Company (DESCO) Ltd., a publicly listed Company engaged in distribution of electricity in the northern part of Dhaka City including part of Gazipur City Corporation seeks qualified candidates from the bona fide citizens of Bangladesh for the **Executive Director** (Engineering) & Executive Director (Procurement) positions on contractual basis for an initial period of 3 (three) years. Brief job description and job specification of the post including other relevant information are as follows:

Job Description: Executive Director (Engineering)

The Executive Director (Engineering) will be the head of the Engineering Directorate of the Company and shall report to the Managing Director. The incumbent shall act as a member of the top management of the Company and shall coordinate and manage the overall functions pertaining to engineering activities. The incumbent shall also be responsible to comply with relevant laws, rules and regulations of the govt. and the prevailing policies/procedures of the Company in order to ensure good governance including formulation/development of necessary plans/policies/procedures/operational manuals etc. pertaining to the company functions. He should carryout duties as per approved job description.

Job Description: Executive Director (Procurement)

The Executive Director (Procurement) will be the head of the Procurement Directorate of the Company and shall report to the Managing Director. The incumbent shall act as a member of the top management of the Company and shall coordinate and manage the overall functions pertaining to procurement activities. The incumbent shall also be responsible to comply with relevant laws, rules and regulations of the govt. and the prevailing policies/procedures of the Company in order to ensure good governance including formulation/development of necessary plans/policies/procedures/operational manuals etc. pertaining to the company functions. He should carryout duties as per approved job description.

Age

Minimum: 45 years, Maximum: 60 years. Age would be calculated on 16/11/2025.

Tenure of Appointment

The initial contract will be for 3 years subject to the maximum age limit of 65 years. It can be extended for two more terms of 3 years subject to the maximum age limit of 65 years in case of competent candidate.

Compensation Packages
